

# Farm to School Education Coordinator

#### POSITION DESCRIPTION:

The Farm to School Education Coordinator will play a key role in facilitating Greater Newark Conservancy's Farm to School education programs which serve elementary and secondary schools throughout Newark. The Coordinator will interface with our Newark public school partners, FoodCorps NJ/NYC team, and FoodCorps service members serving at the Conservancy. The Coordinator will provide technical assistance and support to schools throughout Newark seeking to create and sustain garden programs.

This position will support the Conservancy's mission by building a robust garden-based education and farm to school movement in Newark.

### **SCHOOL INTERFACE: (30%)**

- Meet with school representatives to develop a school year plan using the FoodCorps Menu and Action Plan
- Maintain regular communication with school advisors
- Conduct regular visits to schools for classroom observation, garden technical support,
- Assist FoodCorps service members in planning year-long calendar of taste tests
- Work with Director of Youth and Family Education to review and revise Farm to School curriculum
- Collect, organize and maintain evaluation records including program goals, metrics, outcomes and achievements; and assist in preparation of evaluation reports

### **SERVICE MEMBER SUPERVISION: (30%)**

- Direct and train FoodCorps service members
- Facilitate weekly group and individual check-in meetings

### **FOODCORPS INTERFACE: (10%)**

- Review and approve weekly service member timesheets
- Participate in required FoodCorps training and meetings

### **SCHOOL GARDEN SUPPORT: (30%)**

- Supervise teen interns to provide summer school garden maintenance
- Conduct site visits and provide technical assistance and consulting support to schools

Help build Newark Network of School Gardens; produce regular social media posts;
 write monthly newsletter; assist in creating and hosting workshops
